Landed estates

We have advised a landed estate client (£200M+) for several generations involving the creation of various family trusts to own much of the land and advice about estate planning for example, the gift and leaseback of chattels and reversionary lease planning in relation to the manor house.

Wills, trusts and inheritance tax and capital gains tax planning

We advise extensively in relation to this. For example, we advised a client (£100M+) about how best to draft his will to look after his wife and children from a former marriage. We prepared a will including a discretionary trust to receive business and agricultural assets and a flexible life interest trust for the remaining assets. This enabled the executors/trustees to look after the surviving spouse with the flexibility to transfer funds to children in a tax efficient way. It can also help protect the estate for the next generations from the risk of death, divorce, or bankruptcy of the beneficiaries.



Case studies

Sale of land

We acted for a farm landowner who entered into an option to sell the land subject to planning residential developer. Planning was granted for 150 homes and the property was sold. At the same time as the sale a new option was granted to the developer over the adjoining farmland for potential future residential development. The sale also required a surrender of an existing Farm Business Tenancy (FBT) affecting the land to obtain vacant possession.

Contested sale

We advised a significant agricultural landowner client, who entered into a sale contract in 2015 for the sale of a substantial area of agricultural land for residential development and which it wished to bring to an end. The client's previous solicitor had served notice terminating that contract and entered into a new contract with a third party, conditional on termination of the first contract. Unfortunately, the client's previous solicitor died, and we had to step in at extremely short notice to deal with the contested termination. Two Counsel's opinions were sought at various points of the procedure and, in the end, the sale was completed with the overage capable of being bought out separately.

Diversification

We acted for a longstanding estate client, on a diversification scheme for the landed estate that involved converting derelict buildings on the estate into a retail village for commercial lettings.

We were instructed to assist with the set up and structure of the site and lettings, including infrastructure, construction and commercial lettings. We have been instructed to deal with the site set up and commercial lettings of an extension to the development.

Farm acquisition

We acted on the acquisition of a 140-acre farm made up of four parcels of land from three separate sellers, all separately represented. The transaction involved two main acquisitions followed by an immediate land swap, to provide an access strip between the areas of land purchased. A significant part of the land was subject to a FBT, which added a further complication and required advice on entitlements and compensation.

We successfully liaised with the other lawyers involved to negotiate a simultaneous exchange and completion of all three transactions, as the client had requested.

Regulatory

Our criminal, compliance and regulatory team is well used to reacting to fatal and serious accidents which often raise issues covering police involvement, privileged internal investigations, disclosure to the HSE, access rights to documents and equipment, questioning of employees and contractors and the appeals against improvement and/or prohibition notices.

The team both prosecutes and defends, regularly supporting business and individuals in a wide range of sectors, including those within the agricultural sector.

This includes:

- Defending companies/partnerships and individuals facing gross negligence/ manslaughter investigations/ health and safety investigations involving commercial and farm related accidents. These could result in investigations by all types of linked government bodies including HSE, Environment Agency, BIS, DEFRA and HMRC.
- Alleged breaches of the Animal Welfare Act 2006 and the Protection of Badgers Act 1992.
- Acting for farmers and members of the shooting fraternity in firearms related offences; successful appeals to the crown court for firearms revocation cases.

- Advising on health and safety aspects applicable to commercial shoots.
- Local authority trading standards investigations involving milk contamination; animal tagging/ passport breaches; animal cruelty cases involving the importation/ sale/transportation of livestock; alleged breaches of the Food Hygiene Regs 2006; Egg and Chick Regs 2009.

Health and safety prosecution

We supported a smallholder when a volunteer died becoming entangled in an unprotected power take-off shaft. The smallholder faced two charges under the Health and Safety at Work Act (to which he pleaded guilty) and a change of gross negligence manslaughter (to which he pleaded not guilty) and faced up to 18 years' imprisonment.

We supported on the initial investigation, interviews with police and initial court hearings. The case involved the examination of expert audio and photographic evidence along with vulnerable witnesses, two of whom required special measures during their evidence. Although convicted he was sentenced on the basis of medium culpability and sentenced to four and a half years.

Environmental Agency investigation

We supported a landowner client in relation to an Environment Agency investigation. The incident arose from the irrigation of fields with "dirty water" from the farm; namely, rainwater run-off from the concreted road, outside yard areas within the farm and parlour washings.

The farm used a Briggs Irrigator to irrigate the fields using the dirty water. On a particular day the irrigator caught a land drain, and an amount of dirty water directly entered the drain, subsequently passing into an adjacent brook causing pollution. The investigation by the Environment Agency revealed high ammonia readings which, it was suggested, evidenced that the polluting event was not a single event.
