## Our experience

- We're advising on the first cross-county, mayoral-led combined authority devolution deal in the country. The project, co-led by Nottinghamshire County Council, Nottingham City Council, Derby City Council and Derbyshire County Council provides a unique and unprecedented opportunity for the authorities to come together to deliver much-needed investment into the region.
- We advised the London Borough of Croydon on constitutional changes required to enable them to move to a mayoral executive.
- We provided governance and constitutional advice to the senior leaders of 17 councils and two National Parks on a proposal to form the Heart of the South West Combined Authority.

We helped the Board to bring together the statutory organisations, including the Mayor and national partners who each have a role in service design and delivery.
- After supporting with their initial business case and submission to the Department for Levelling Up, Housing and Communities, we're advising the project in the establishment of Freeport East, one of just eight special economic zones countrywide. Our experts are overseeing all administrative and legislative aspects, subsidy control and their new corporate structure.
- When the recently incorporated East Midlands Development Corporation was established, we provided legal support to three of the five founding members, advising on the company's constitution, governance, membership, and funding arrangements.
