Wales Infrastructure Bill: Unified process for significant infrastructure projects?

The Infrastructure (Wales) Bill was laid in the Senedd on 12 June 2023. The Bill reforms how infrastructure is consented in Wales. It establishes Infrastructure Consent, a unified process for specific types of significant infrastructure projects. Significant infrastructure projects include energy, transport, waste, water and gas projects both on land and within the Welsh marine area.

Local authorities contracting out enforcement of debts

The question for the Technology and Construction Court and Administrative Court in *Dukes Bailiffs Limited v Breckland Council* [2023] EWHC 1569 was whether a local authority contracting out enforcement of its debts is governed by the Public Contract Regulations 2015 or the Concession Contracts Regulations 2016, or alternatively, whether the local authorities decisions in this regard are open to judicial review.

Review of a subsidy control decision: The Durham Company Ltd v Durham County Council, 27 July 2023

The Durham Company Limited (t/a Max Recycle) v Durham County Council, 27 July 2023 is the first application for a review of a subsidy control decision under s.70 of the Subsidy Control Act 2022 (Act) to come before the Competition Appeal Tribunal and has been awaited with some anticipation by those advising local authorities on subsidy control, because of its potential implications for local authority 'commercial' operations.
