These claims raise multiple, formerly untested, areas of cross-border insolvency law, involving billions of dollars redemptions and fees paid prior to the collapse of Madoff's infamous Ponzi scheme.
- Acting as virtual General Counsel to the parent company of Twin Hill Acquisition Co, Inc to advise on litigation strategy and key risk issues arising from a suite of product liability claims in the US seeking up to \$500m in damages due to allegedly defective uniforms manufactured by Twin Hill for 65,000 American Airlines employees.
- Acting in follow-on private damages actions before the Irish High Court following decisions from the European Commission, European General Court and European Court of Justice.
- Successfully challenging the jurisdiction of the Irish High Court to determine an intellectual property right infringement claim brought by easyGroup against the firm's Cyprus-based client.
