Legal Director and former partner at the firm, <u>Alan Radford</u>, who specialises in defending professional negligence claims against solicitors and members of the Bar was given the 'President's Award' for his outstanding contribution to the legal profession and the Nottingham legal community. He was also praised for his service to the Nottinghamshire Law Society, having acted as President, between 2015 - 2017 and his distinguished contribution as the society's Honorary Secretary.

Associate lawyer <u>Hannah Collins</u>, who specialises in social care litigation, advisory and public law, was also awarded the coveted 'Junior Lawyer of the Year' title.

In addition to these awards, partner <u>James Arrowsmith</u> and associate lawyer <u>Lynette Wieland</u> were also shortlisted in the Diversity & Inclusion category.

Alan, whose legal career spans over 40 years, qualified as a litigation lawyer in 1982 and joined Browne Jacobson's insurance practice in 1991. In 2013 he was appointed as the Chair of The Law Society's Professional Indemnity Insurance Committee of which he remains a current member and is also Chair of the Nottinghamshire Law Society's Professional Purposes Committee. He has been very active on the corporate social responsibility side, previously acting as a trustee of Reach – a charity which provides support, accommodation and activities for adults with learning disabilities.

Hannah joined Browne Jacobson in 2015 as an Administration Assistant, and recently qualified as an Associate Solicitor at the firm. She is a key member of Browne Jacobson's internal Diversity & Inclusion (D&I) steering group where she has an active role in educating the firm on LGBT+ related matters and championing related initiatives. She has also been pivotal in organising and promoting in person and virtual Pride and LGBT History Month events at the firm and has co-ordinated the firm's involvement with external Pride marches. Hannah is also part of the Nottingham Community Action Group, supporting the Nottingham office charity partner, Inspire & Achieve.

Last year she helped drive the set-up of the East Midlands branch of the Alliance Network through her participation in an external LGBT+ steering group. As a result, the firm now collaborates with the Network which brings together some of the region's most diverse employers and LGBT+ professionals and staff networks from across the region.

Hannah was also listed in the OUTstanding LGBT+ Future Leaders Role Model List for 2021 for her work in breaking down barriers and making a significant contribution to LGBT+ inclusion within the workplace.
